
Our entry into this past year was busy and crowded, in sharp contrast to the usual quiet experienced in the country in the winter months. A final total showed that we were host to over thirteen thousand skiers in the eighty days of skiing at our new ski area on the Westminster-Princeton line. Difficulties, both mechanical and operational, were experienced, but other area operators tell us that this is normal for the first few years of operation and will gradually disappear as our experience factor improves.

A number of improvements in the ski area in the form of drainage, regrading, culverts, access ways, larger and smoother run-out areas, parking lot, building foundations and ticket booths were made during the summer months and, in the few days that we had to observe their operation in late December, showed that they were well worth our efforts. Other improvements will undoubtedly be indicated as we get further into the season, and as in the past, we will make note of these and implement them as soon as practicable.

Severe cuts in our estimated budget for the year made any tar road maintenance out of the question but we did manage to make some needed improvements in our gravel roads. It is hoped that we can continue this program in the future and also do more than just patch our black top roads.

Our building maintenance program was also severely curtailed, in fact, the only exterior maintenance that could be scheduled was the painting of one dwelling, and we had trouble fitting that into our limited funds.

As in the past few years, our cordwood harvest was taken from land that was to be used as a part of the ski area. Most of this wood has been stacked at the ski area and will be used in the Chalet that is now building, as well as at the picnic and other group activity areas on the Reservation.

Once again our summer visitor use remained high, with counts, estimates, and samplings indicating about 150,000 visitor-days. We find that campers and organized groups account for about 2,000 of these with the rest being made up of sightseers and picnickers. While there is considerable agitation to enlarge the ski area so that it can accomodate more skiers, it should be noted that they account for only one-tenth of our visitor use at this time, and careful thought should be given before indiscriminately taking over additional acreage for a small percentage of users. While it is felt that this area should be further developed in the future, and was so designed that additional developement will fit in without disrupting the present set-up, extreme care must be taken to insure that any such additional developement will not upset the balance, appearance or beauty of the Reservation.



Dear Mr. Campbell:

I have received your letter of November 15, 1963 relative to the Wachusett Mountain State Reservation ski area authorized by St. 1960, c. 679. You have indicated that you wish to lease the ski facilities for operation by private parties, and have posed five questions with regard to such an arrangement.

I will not treat with your specific questions herein because I find no authorization for the Commission to enter into this type of leasing arrangement. Chapter 679 of the Acts of 1960 provides that the Commission is "authorized and directed to construct, maintain, operate or lease on Wachusett mountain, a ski area with facilities appurtenant thereto". In the absence of language in the act to the contrary, this reference to a lease refers to the right of the Commission to acquire facilities by lease, and does not imply that the Commission may itself lease the facilities to others.

Chapter 679 clearly sets forth the way in which the business of the ski area is to be managed. Section 3 authorizes the Commission to charge reasonable fees for use of the facilities, and



directs what disposition is to be made of income that exceeds expenses. Section 4 provides that where expenses exceed funds derived from use of the facilities, the necessary funds shall be assessed and collected as are county taxes. Under § 5, the County Treasurer holds all sums raised by taxation for the ski area, as well as all other sums given or bequeathed for that purpose. A leasing arrangement which would relieve the Commission of these problems of income and expenses is clearly not contemplated. Leasing of the facilities to private parties would make the careful provisions of c. 679 unnecessary, and should not be considered without specific authorization.

Furthermore, when the General Court has felt it desirable to permit a leasing arrangement it has said so. Chapter 755 of the Acts of 1957 authorizes the Commission to lease certain land in the State Reservation. Had the Legislature envisaged leasing of the ski facilities, it could have provided for it in the same manner. I am aware of the fact that other States do permit the leasing of State ski areas, and that such is frequently most practical from a business point of view. However, absent specific authorization by statute, I must advise you that the Commission does not have the right to enter into the proposed lease.

Meeting was opened by the Chairman and it was moved and voted to dispense with the reading of the minutes of the previous meeting since all of the Commissioners had received copies of these minutes.

It was noted that Commissioner Trinder was in the hospital and all of those present wished him a speedy recovery. The Superintendent was instructed to convey this wish to Mr Trinder.

It was moved and voted to ratify the letter written by the Superintendent to Governor Peabody on the 6th of January and the letter is hereby made a part of these minutes.

It was noted that Strand Mikkelsen approached the Superintendent with a letter stating that he would discontinue operation of the Ski Shop because of difficulties of doing business at this location unless an adjustment of the agreement of 1961 was considered immediately by the Commission. The Superintendent polled the Commission and the reaction was that it would take about a month to secure bids and negotiate a contract with a new operator and it might very well take a much longer period for such an operator to secure the necessary rentals, inventory, etc. It was the feeling of the Commission that the best interests of the public and the Ski Area would be served by continuing on the terms demanded by Mr Mikkelsen, namely 10% of the gross, and such an agreement was entered into by the Superintendent and Mr Mikkelsen on the 2nd of January 1964.

It was moved, seconded and voted to ratify and confirm the action of the Superintendent on the above.

The Chair then stated that part of the agreement above was that this agreement would terminate at the conclusion of the current skiing season in April 1964 and new bids for the operation of this concession would be requested at that time.






The meeting was opened by the Chairman and copies of the minutes of the previous meeting were distributed to all present. It was moved and voted to accept the minutes as appearing in the record.





The meeting was opened by the Chairman and the minutes of the last meeting were read. Moved, seconded and voted to accept them.

The Annual Report by the Superintendent was read and discussed. Voted to submit the report to the County Commissioners.

A letter from Dr John Connor, concerning the Summit House Concession, was read and discussed. This letter is attached to these minutes. Bidding of the Summit House Concession and the Ski Chalet Concession together was discussed and it was decided to invite bids for the letting of the concessions for either or both the Summit House and Chalet, with the Commission reserving the right to reject any or all bids, to let either concession individually, or to accept the bid or bids in the best interests of the Reservation.. The bid invitation to specify that the rent or rents be in lump sums (not percentages), that the coin locks and cleaning of the Summit toilets be a part of the Summit House concession, That the bidders give a summary of their experience and/or qualifications, that there will be no subletting of either of these concessions without the express permission of the Commission. It was also decided that the invitation or specifications should note that certain equipment now installed at the Summit House and belonging to Dr Connor could be purchased from him by private treaty, and that minimum equipment requirements for the Chalet be substantially as indicated in the report from the Haddad Equipment Company.

The Superintendent was instructed to draw up a suitable invitation and specifications to cover the above, and to submit them to the Commissioners for approval. It was tentatively decided to hold a meeting at the County Court House on 1 April 1964 at 2:00 o'clock PM to open and read these bids.

It was also decided to invite bids for the operation of the Ski Shop at the same time. The Superintendent was instructed to notify Strand's Ski Shop of the Commission's intention to ask for new bids on the Ski Shop.

The income and expenses for the 1963 calendar year were discussed and the Superintendent was instructed to recheck his figures and submit a report to the Chairman.

The Superintendent was also instructed to inquire as to the status of any decision by the Director of Accounts and/or the Controller as to the operation of the Ski Area Fund, and to report his findings to the Commission.

Motion was made, seconded and voted to retain the present Chairman and Clerk in office on the Commission for the coming year.


It was suggested that the Superintendent make an estimate of work to be done and expenditures to be made for approval by the Commission before making any extraordinary expenditures.



Meeting was called to order by the Chairman and the Ski Shop Bids, which were due at this time, were opened and read. The bids were as follows:

Strand's Ski Shop, Inc.	\$750.00
Ralph White's Ski Shop	450.00 min. or 20% of net proceeds of sales and rentals
Normand D Letarte	2,000.00 or preferably 15% of gross sales and rentals.
Robert A Ewer	900.00

Mr Campbell asked about stocks of equipment and supplies which were mentioned only in general terms in the bid forms and was told by the Superintendent that the public established the levels of supply needed in an operation of this type and that the Concessionaire would not let his stock fall below that needed to completely fill the demands and requirements of the Area users.

Mr Letarte was invited to make a statement on his bid and showed the rental forms which he contemplated using, and spoke briefly on the quality and amounts of merchandise and rental equipment he would keep on hand. He also stated that he would have a full time operator on hand at all times.

Mr White also outlined his proposed operation of the shop, giving a brief background of his long experience as a Ski Shop operator, mentioned the merchandise and rental equipment he would stock and stressed that he would employ non-skiers to operate the shop so that they would not tend to leave the shop to ski.

The Commission then took the Ski Shop bids under advisement.

Before opening the Snack Bar bids, Mr Liberatore stated that a Mr Greco of Fitchburg, who had wished to bid on the Chalet Snack Bar, had not received a copy of the bid form and had complained to him a day or so before. The Superintendent stated that he had mailed a copy (#1) to Mr Greco at the address he had given in a letter to the Superintendent, just as he had to several others who wished to bid and had so notified him. This form was mailed on the 25th of March.

The lack of a number of bids was discussed. The Chairman stated that he would prefer to act on all the bids now, either to accept or to reject them.

A motion was made and seconded to separate the Summit House and Chalet bids. This motion was carried unanimously.

Motion was made, seconded and unanimously voted to award the operation of the Summit House and allied concessions to Robert C Vickery of Sutton.

Motion was made, seconded and unanimously voted to reject the Chalet Snack Bar bids and to set up an invitation for sometime in the future. A date was not selected at this time.

The Ski Shop bids were discussed and the Superintendent asked for an opinion the bidders. He stated that he could work and get along with any of the bidders.

It was moved that the Ski Shop be awarded to Ralph White's Ski Shop at the 20% of sales figure, if the term "net proceeds" meant "gross". An effort to contact Mr White for an explanation of his bid was unsuccessful. The Motion was not seconded.


Moved to accept the bid of Normand Letarte and award the Ski Shop to him. Motion was not seconded.

After a further discussion, it was moved, seconded and unanimously voted to reject all bids for the Ski Shop and to issue a new invitation for bids to be received and opened at 10:00 AM Monday, 13 April 1964.

Minutes of the previous meeting discussed and accepted as written.

The case of a Mr Feld who was injured at the Area was discussed and the Superintendent was instructed to send a letter stating that the Area had no insurance to cover such an accident. (fell off lift)

Motioned made, seconded and voted to accept the records on the operation of the Ski Shop for January and February as presented. The gross income was \$4,630.50 for the period and the rent, therefore, was \$463.05.




Meeting of 1 April 1964

The meeting was opened by the Chairman and the bids for the operation of the Ski Shop were opened and read. The bids were as follows:

The bidders present were invited to offer any statement they might care to make to the Commission by Mr Liberatore, but since no statements were offered the Chairman announced that the Commission would take the bids under advisement.

The minutes of the previous meeting were read by the Commissioners and it was voted to accept them as written.

A recapitulation on the operation of the Ski Area for the past season (from January 1st only) was offered by the Superintendent and discussed. Income for this period was listed as \$33,029.30 with expenses of Payroll at \$11,011.13 and Supplies at \$20,413.90, leaving a net of \$1,602.27.

Bids for the Ski Shop were discussed and since Mr White had offered in his bid to make payment of the minimum by 4 January 1965, Mr Letarte offered to make similar payment by the 5th of January 1965. It was decided to consider only the two highest bids offered, namely those of Mr White and Mr Letarte.

The Chairman announced that the Commission would go into Executive Session to consider the bids and this was done at 10:50 AM.

A further discussion of the bids was held and it was moved, seconded and passed by a majority vote to award the operation of the Ski Shop to Ralph White's Ski Shop. Mr Trinder was opposed.

The Commission came out of Executive Session at 11:23 AM

A report on the progress of the Chalet was given by the Superintendent and accepted.

Use of Reservation

Because of the difficulty of controlling the use and misuse of the Reservation throughout a seven day week and twenty-four hour day, it is recommended that strict hours and dates of opening be instituted, and that the feasibility of charging an entrance fee be explored.

Closing of the Reservation would produce some difficulties of control but it is thought that the "dead ending" of all Reservation roads at their outer ends, with the exception of the Summit Road, and the construction and constant manning of a contact station at the foot of the Summit Road would answer most of these difficulties. An arrangement of this type would control only auto traffic, but it has been found that this traffic is our major headache.

Hours of opening and any fees charged could be patterned after those of the Department of Natural Resources, to which the public is already conditioned. These would be from 10:00 AM to approximately sunset, with a charge of one dollar for entrance, per car. Dates of operation of the "Summer" section of the Reservation would probably be from the weekend (before) nearest the 30th of May until the first weekend after the 12th of October.

Benefits to be derived from such action would be an opportunity to eliminate, or at least identify, after dark users. Most of our damage and misuse occurs during the hours of darkness and by occupants of vehicles. Control of this nature should materially reduce rubbish accumulations and vandalism without interfering with the normal public use of the area. Charges for admission would add somewhat to the Reservation's income, and might possibly be used as a pry to obtain sufficiently generous budget allowances to carry on adequate maintenance on all phases of operation.

Disadvantages would be the initial and upkeep expenses of constructing turnarounds at the ends of our roads (The Reservation is now accessible through six entrances), contact stations, gates, etc. Another continuing expense would be the additional personell necessary to man the contact station on a 24 hour basis during the open season and during the day for early spring and late fall. Manning such a station during the open seson would require approximately 84 man-weeks of time.



The meeting was opened at 11:00 AM by the Chairman and the minutes of the previous meeting were discussed. Voted to approve the minutes as written.

Requests by the Massachusetts Society for the Prevention of Cruelty to Animals and the Division of Food and Drugs of the Massachusetts Department of Public Health to install radios at the Summit of the Mountain were presented by the Superintendent and discussed. It was decided to table both of these requests, without action.

A request by the Department of Natural Resources to build a metal tower for their Fire Watcher at the Summit was presented by the Superintendent and discussed. It was suggested by the Commission that the Superintendent write Mr Hurley of the Department of Natural Resources and suggest that he might study the proposed plans for a new building at the Summit, now in the Bureau of Building Construction, and possibly assist the Commission in obtaining sufficient backing from his own and other State Agencies to have this building constructed, in lieu of erecting a metal tower.

A recommendation by the Superintendent on restricting the use of the Reservation (copy attached) was discussed by the Commission and taken under advisement.

A letter from the Superintendent to Mr Meagher, Concessionaire at the Summit, concerning the closing of all roads on the Reservation on the 19th of October was brought up by Mr Liberatore and the Superintendent was questioned as to the reason for this proposed action. When advised of the time necessary to prepare the Ski Area for operation and the danger of having public access to areas crossed by pipelines and T-bars, the Commissioner instructed the Superintendent to write Mr Meagher that the Commission confirmed the Superintendent's action and that the Reservation would be closed on the 19th.

Report of the Superintendent to the Commission on the progress of negotiations with the Sheriff of Worcester County concerning the use of prisoners on the Reservation was accepted and it was noted that the Sheriff's department did not have sufficient funds to hire the guards necessary to bring such labor to the Reservation.

It was suggested by the Commission that signs "Trucks Excluded" might be posted at all entrances to the Reservation, to prevent the possible damage that large trucks might inflict on our trees and structures.

A report from Norrand Letarte on the brief operation of the Ski School under agreement at the Area for the 1963-64 season was discussed and it was decided that if he would sign it "True copy - Attest" then the Commission would accept it.

The Superintendent was requested to attend the meeting of the Eastern Ski Area Operator's Association in New York on the weekend of 17 - 18 October and it was moved, seconded and voted that expenses connected therewith might be collected from the Area.

The installation of a well for the Chalet by the Superintendent as ratified.

A possible date for an opening ceremony at the new Chalet was discussed and it was thought that late November might be suitable. In connection with this the subject of a suitable plaque for the building and the Area was discussed and the Superintendent was instructed to investigate the cost, etc. A name for the Chalet was also discussed and Representative Ernest Johnson, who did so much to help establish the necessary legislation, was mentioned. Decided to hold this over to the next meeting.

Decided to hold the next meeting on the 21st of October at 10:00 AM at the Ski Area and to accept bids for the brochures at this meeting.



Gentlemen:

Our second season of operation of the Mount Wachusett Ski Area seemed to go very well during the winter and early spring, although there were only 69 skiing days from Christmas 1963 until we ran out of snow on the 23rd of March 1964. Many improvements were made during the summer months, including much of the installation work on the snow maker, and considerable grooming of our existing trails. A new Ski School slope was cut and rough graded in time for use during the new season. Anticipation of an early start in December did not materialize, due to a complete lack of natural snow and unavoidable delays in the installation of the snow maker, and we ended the year in the red. It is hoped that snow will be plentiful for the rest of the season, and that we will be able to have a good operational report for 1965.


Our budget estimate for the Reservation maintenance was cut severely, and we were only able to do the very essential of our normal maintenance requirements. Rubbish collection was curtailed, no major painting or building maintenance was attempted, desirable improvements to the sanitary and water supply facilities at the Summit were foregone and our tar roads were merely patched for another year.

Our visitor count remained high, being again in the area of 150,000 to 170,000 visitor days. In spite of the extremely dry weather throughout the summer and fall, and the high visitor use, we had only one small, quickly extinguished fire. It is hoped that our precipitation will be more nearly normal for the coming year, so that our high visitor use will not entail as much extra duty patrolling as last year.

We have on hand the Certificate of Inspection and Acceptance for the above mentioned project which your office wishes to have signed by an authorized representative of our Commission.

At a meeting of the Commission held on 6 February 1965 a number of questions were raised concerning the Ski Lodge and our responsibility in connection with them, as listed below.

1. Fireplace. There is still a serious smoke problem in the lounge area of the Lodge. Some changes were made in the smoke hood, but their effect was negligible. A Mr Fredette of the Building Inspection section of the Department of Public Safety informs us that a screen is required, by State Law, on the fireplace before a certificate of inspection will be granted. It would seem to this department that the designer should be sufficiently familiar with the laws of the Commonwealth to insure that his designs complied with them.

2. Emergency lights. There are still no batteries of any description in the emergency light cases. Mr Fredette also stated that these were absolutely essential before a certificate could be granted.

3. Entrances and service doors. There are extremely annoying and unsightly drips over all entrances and service doors in the service section of the building. No provision was made by the designer to carry roof drip away from the area directly above these doors. This drip causes ice to build up, preventing the complete opening of the doors and frequently hits people using the doors. The main entrance door for the public does not lock securely unless a great deal of time and effort is made to be sure that the latches have actually engaged with the door frame. The walk ways on the outside of the building are on the same level as the interior floor and do not provide any space for snow or ice

accumulation under the swing of the doors. It would appear that a space of about six inches should have been provided in the design.

With the exception of the batteries in the emergency lights, all of the above problems are directly attributable to the design of the building. Who is responsible for correction of these? What funds would be used to defray the expense of this correction? Our Commission feels that these questions should be answered before they approve any Certificate of Acceptance.



Bids for the operation of the Ski School at the Ski Area were received, opened and read. Two bids were received, as follows:

Masn Flagg of Worcester	\$10.00 annually
Ollie Manninen of Westminster	\$1.00/day of operation

It was moved, seconded and voted to consider these bids in executive session.

Mr Ralph Meagher, concessionaire, was present and requested that, since he is forced to carry all water for drinking purposes to the Summit, he be granted a reduction in his rent of \$1,001.00 to \$550.00. He also requested that the Reservation purchase new shades for the windows in the Summit House and that the old telescopes belonging to the Reservation be loaned to him for repair and possible use at the Summit. It was explained that these telescopes were so badly damaged that they were considered non-repairable five years ago.

A discussion was held concerning the operation of the Summit concession last year, and its current operation so far this year, with comments on cleanliness, prices, portions, help, etc.

Dr John Connor, the former concessionaire at the Summit, was also present and made several comments on his operation of the concession over a period of 17 years, and also stated that Mr Meagher was in arrears on payments to him for the equipment and stock sold by Connor to Meagher when concession changed hands. Dr Connor suggested that he might have to employ legal action to collect this money and wanted the Commission to know about it before any such action was taken.

The Commission voted to go into executive session to discuss the Ski School bids and the request for reduction in rent, at 8:45 PM

Minutes of the meeting of February 6th were accepted as written.

Motion was made, seconded and unanimously voted to award the Ski School to Ollie Manninen. The Superintendent was instructed to notify Mr Manninen of this action.

Motion was made, seconded and voted not to reduce the rent of the Summit House concession for this year.

A suggested Season Pass policy for the Ski Area was discussed and approved. A copy of the policy is attached to and made a part of these minutes.

The use of volunteer labor on the ski trails at the Ski Area was discussed and approved providing a suitable release is drawn up for signature by such volunteers to relieve the Reservation of liability in the event of accident. Generally the use of such labor provides that for each 24 hours of labor one season pass to the Ski Area will be awarded. No volunteer would be required, or permitted, to use any vehicles, power or dangerous tools in this work. No Volunteer would be allowed to earn more than one season pass, and any such pass earned would be only for the earner or a member of his immediate family (father, mother, son, daughter, Brother, sister relationship). It was suggested that a limit of fifty passes should be set for this year.

The Acceptance and Inspection Certificate for the Chalet was discussed and the Superintendent was instructed to write a letter to the Bureau of Building Construction requesting that they either remedy the various complaints about the building or assure the Commission that they will be taken care of at no expense to the Reservation of Ski Area.

The Chairmanship of the Commission was discussed but no action was taken.

Motion was made, seconded and voted that Mr Breau be Clerk of the Commission.

Gentlemen:

This Commission has discussed the problem of vandalism several times in an effort to find a method of preventing it without curtailing the public's use of the Reservation. It would seem that any effective method would require an expenditure of considerable funds for the coverage indicated.

Probably the system which would require the least capital expenditure, and which could be readily expanded or reduced in accordance with the need, would be the establishment of a roving patrol. It is contemplated that this patrol would be composed of either temporary employees with police powers, or local police officers, and that it would cover the entire Reservation between the hours of 8:00 PM and 4:00 AM.

For a number of years the trend has been towards increased vandalism at the Reservation, although the bulk of the acts have been of relatively minor nature and fairly easy to repair. Recently, however, Bullock Lodge was extensively damaged and has had to be boarded up until arrangements can be made for repairs. It is believed that this damage occurred between midnight and daylight on a Sunday morning.

While the cost of patrolling would probably be in the neighborhood of \$2,000.00 per season, it is felt that possible damage to Reservation property could exceed this cost several times under the right circumstances.

Will you please advise us of your feelings in this matter so that we may proceed with a course of action that will be in the best interests of the County and the Reservation?

The report of the Superintendent on the volunteer work program at the Ski Area was read, discussed and approved. A copy of this report is attached to and made a part of these minutes.

The production and laminating of Season Passes to the Ski Area was discussed and it was moved, seconded and voted to authorize the Superintendent to obtain cold laminating material and an instant picture camera, if and when funds are available from Ski Area income.

The Superintendent reported to the Commission that he had contracted with the Princeton Congregational Church to take the Chapel Bell from the East Princeton Chapel for use at the Ski School on a "rental-purchase" plan of \$150.00, payable in three annual installments. The Commission moved, seconded and voted to ratify this action.

The budget estimate for calendar year 1966 was presented by the Superintendent and discussed. The estimate was approved as presented and the Superintendent was instructed to forward this estimate to the County Commissioners for their consideration. A copy of this estimate is attached to these minutes.

The Chairman discussed the payment to the Superintendent of additional recompense for his work on and at the Ski Area, and what had happened to legislation which had been filed for this in the past. He further suggested that he file a bill to this effect for consideration during the coming session of the General Court. The Commission concurred.

REPORT ON VOLUNTEER WORK-PARTY PROGRAM

A total of 77 people were signed up to participate in the volunteer work program at the Ski Area. Of these, 11 did not show up for work on any of the days scheduled, 57 have completed the required 24 hours of work and are entitled to their passes, and 9 others have partially completed the requirements.

On the basis of 66 completed requirements, the Ski Area will give out passes valued at \$2,310.00. Administration of the program took approximately 12 days and should be figured at about \$300.00 cost. Tools accounted for an expenditure of about \$95.00. Paint and other material cost approximately \$35.00.

Estimated total cost of the program to the Ski Area is about \$2,740.00.

Approximately 18 acres of trails and slopes were completely hand groomed, and in some areas extensive construction work was done. The estimated cost of grooming would be about \$60.00 to \$75.00 per acre, for a total value of grooming work done of \$1,080.00 to \$1,350.00. Construction work done on the trails and slopes would have a value of approximately \$250.00.

5500 feet of lift lines were hand graded, groomed, and covered with hay. In several areas extensive construction work was necessary. Estimated value of the grading, grooming and covering would be about \$200.00 per 1,000 feet for a total value of \$1,100.00. Construction work on all lift lines would be worth about \$200.00.

All Tees and Tee-hangers were painted, a total of about 375 pieces. The estimated value of this work is about \$150.00.


Three of our regular A-frame buildings were stained and portions of both base lift houses were also covered. One of the lift shacks was stained. Approximate value of this painting is about \$300.00

3,000 brochures were altered by pasting in Ollie Manninen's picture and the Ski School write-up. Estimated cost of having this done is about \$45.00.

Over-all total estimated value of the work done by the volunteer groups - \$3,125.00 to \$3,395.00

In addition to the apparent financial advantage to the Ski Area, comments received from various sources indicate that we have added at least 66 loyal, articulate, supporters to our ranks. It would also appear that up to 75 additional passes will be purchased by those volunteer workers who have families that ski.

The program would appear to have been a complete success and it is recommended that it be continued on about the same basis in future years.



To the Honorable Board of County Commissioners

Gentlemen:

Through the summer months we did what maintenance we could to the road net and buildings, although we were severely handicapped by a lack of funds, caused by the General Court's delay in approving a budget. No extensive repair or new work could be scheduled prior to our receiving our budget allowances, even though this was sorely needed.

Scraping and regrading of our gravel roads was completed early in the summer and they were kept in good condition throughout the remainder of the season. Some regravelling and drainage work was also done but there is much that needs doing.

No patching or recoating of the blacktop roads was done beyond emergency repairs, since there were no funds available. Most of the blacktop roadsides were trimmed back and low overhead branches cut to eliminate potential traffic hazards. The remainder of this work is scheduled for the coming year and will also include the gravel road net.

Although the entire year was extremely dry and precipitation was far below normal, we had no forest fires on the Mountain and did not have to close the Reservation to the public. Several times we did resort to patrol activity to prevent any possible fire hazards.

Sample counts and estimates showed that we again had about 170,000 visitor-days during the summer months and ticket sales totaled about 15,000 skier-days during the winter season. It is expected that we will continue to gain slowly in the skier department while holding about the same in the summer season.

A complete lack of snow during the month of December, 1964, and most of January, presented a difficult problem to the Ski Area in both finances and operation. However, our regular staff rushed the installation of the snow making equipment and we were able to start making snow on the 7th of January, and opened for skiing on the 22nd. From then until the end of the season we operated the Ski Area for eleven straight weekends and daily except for the last four weeks. We closed for the season on Sunday, the 4th of April with a carnival-like costume party on the slopes.

The experience of the early part of the year with the snow maker proved to be invaluable during December, when we were able to make sufficient snow to open for skiing on the 10th, a full week and a half earlier than any other area in Massachusetts, and two weeks earlier than we had in any previous year. This early start enabled us to reduce our ski area deficit materially and we ended the year with a relatively small loss, in spite of adverse snow and weather conditions. On the basis of this experience and operation we are looking forward to a numerically and financially successful year in 1966.

The Superintendent suggested the organization of a junior racing team and Mr Spear suggested the organization of a competitive demonstration team of junior skiers to help promote the Area. These suggestions were discussed and taken under advisement.

The installation of positive back stops on the lifts at the Ski Area was discussed and the Superintendent explained that such installation would probably be required when a safety code was approved by the State.

The operation of the food concession at the Ski Area was discussed and Mr Spear mentioned the lack of cleanliness of the tables and floor. It was suggested that a cement floor might be more easily cleaned and perhaps should be installed. The Superintendent was instructed to write






The meeting of 13 April 1966 was declared to be an official meeting of the Commission and the minutes of the meeting were approved as written and submitted to the Commissioners.

2. The Superintendent was instructed to investigate the renting of a gas water heater for the Chalet to replace the present electric heater, so that the electric capacity thus relieved could be used by the concessionaire for cooking. The results of this investigation to be brought before the Commission at a future meeting.
3. The gravel floor in the main part of the Chalet was discussed and the Superintendent's recommendation installing brick flooring was brought to the Commission. The Superintendent was instructed to further investigate this material, and any others that might be applicable, and report to the Commission at the next meeting.
4. It was moved, seconded and voted to have the Reservation personnel build a roof over the entrance of the Chalet to relieve the icing condition at the threshold.
5. The Superintendent was instructed to report to the Commission on the feasibility of installing new furniture, (tables and benches) in the Chalet at a future meeting of the Commission.
6. The Superintendent was instructed to report on the necessity of installing an auxiliary gas heater in the lounge area of the Chalet, at a future meeting.

It is requested that you inform this office if the Commission is willing to accept the transfer of this facility, appurtenances and telephone cable, the Government thereafter being relieved of responsibility.


