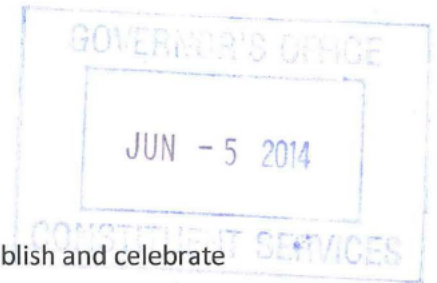

Dear Governor Patrick:

To date, forty (40) U.S. Governors have supported our national effort to establish and celebrate "American Eagle Day" on June 20th by issuing special proclamations (see proposed example attached).

Also, the United States Senate and House have supported our efforts for the past 6 years, and hopefully will do so again this year.

This year, we respectfully request that you and your great state join us to help assure the participation of all 50 states in this special project prior to June 20, 2014.

The not-for-profit American Eagle Foundation (AEF) of Pigeon Forge, Tennessee seeks your support to establish a permanent and annual "American Eagle Day" on June 20th – the day the Bald Eagle was selected as the official national emblem of the United States of America by the Second Continental Congress in 1782.

This would be a special time on our calendar – appropriately positioned between Flag Day on June 14th and Independence Day on July 4th – for the American people to celebrate and remember the successful recovery of the Bald Eagle from the brink of extinction, as well as the important symbolic role this majestic bird has played in our country's heritage, spirit and natural legacy for the past 232 years.

As you know, the U.S. Fish & Wildlife Service removed the Bald Eagle from Endangered Species Act protection in June 2007. However, eagle recovery efforts - including habitat protection and nest monitoring - will be on-going to maintain and continue the progress already made.

Therefore, we must all remain vigilant in keeping a watchful eye over our proud national bird for years to come - as we never want it to become endangered or threatened again.

In 2007, the AEF introduced its first "American Eagle Day" resolution in both the U.S. Senate and House. That resolution and similar resolutions in subsequent years were unanimously passed before June 20th (each year).

Elementary school children, boy/girl scouts, celebrities and civic/fraternal/conservation organizations across the country have joined the American Eagle Foundation in writing letters to various Governors requesting that they proclaim "American Eagle Day" on a state-by-state level.

These young people and others have already created a ground swell of grass-roots support for this wonderful and appropriate idea. This has especially been an important opportunity for America's youth

to participate in the Democratic process and have their voice heard relative to this patriotic conservation issue.

The AEF hereby requests that you and the great State of Massachusetts join us in proclaiming "American Eagle Day" on June 20, 2014.

We have enclosed a sample proclamation for you that 40 state governors have used.

We would greatly appreciate you and your state joining us - as soon as possible - to help accomplish the proclamation of this special and important day in your state.

Americans everywhere must never forget that we almost lost this precious national treasure (and living symbol of our nation) – primarily due to our own carelessness and neglect. But we chose to rise to the occasion and take action. In fact, we cared passionately enough about the eagle's tragic plight to band together and help bring it back to flourishing population numbers throughout America's lands, waterways and skies – hopefully forever.

PROCLAMATION

By The Governor

WHEREAS, the Bald Eagle was designated as the U.S.A.'s National Emblem on June 20, 1782 by our Country's Founding Fathers at the Second Continental Congress; and

WHEREAS, the Bald Eagle is unique to North America and represents such American values and attributes as Freedom, Courage, Strength, Spirit, Justice, Quality and Excellence; and

WHEREAS, the Bald Eagle is the central image used in the Great Seal of the United States and in the logos of many branches of the U. S. Government, including the Presidency, Congress, Defense Department, Treasury Department, Justice Department, State Department, Department Of Commerce and U. S. Postal Service; and

WHEREAS, the Bald Eagle's image, meaning and symbolism have played a significant role in the beliefs, traditions, religions, lifestyles and heritage of Americans from all walks of life, including U.S. military service men/women, American Indians, Christians, and members of various civic, fraternal, patriotic, veterans, youth, conservation, educational, outdoors, nature, sportsman, wildlife, political and sports organizations; and

WHEREAS, the Bald Eagle's image, meaning and symbolism have played a significant role in American art, music, literature, architecture, commerce, education, culture; and on United States stamps, currency and coinage; and

WHEREAS, the Bald Eagle was once endangered with possible extinction, and is making a gradual and encouraging comeback to America's skies; and

WHEREAS, the Bald Eagle was federally classified as an "endangered species" in the lower 48 states under the Endangered Species Act in 1973, and was upgraded to a less imperiled "threatened" status under that Act in 1995; and

WHEREAS, the Department of Interior and U.S. Fish & Wildlife Service delisted the Bald Eagle from Endangered Species Act protection in 2007, but will continue to be protected under the Bald & Golden Eagle Protection Act and the Migratory Bird Treaty Act; and

WHEREAS, the recovery of the U.S.A.'s Bald Eagle population was largely accomplished due to the vigilant efforts of numerous caring agencies, corporations, organizations and citizens;

NOW THEREFORE, I the elected Governor of _____
