Examination of Carols E. Goodridge, at Worcester, Mass.,
October 13, 1922, by Assistant District Attorney
Harold P. Williams.

Mr. WILLIAMS: Have you seen Mr. Fred H. Moore, of counsel for
Sacco and Vanzetti since the trial of those defendants in Dedham?

Mr. GOODRIDGE: Yes.

Q When did you next see him?

A Well, I should say about the tenth of July this year, 1922.

Q Where did you see him?

A Vassalboro, Maine.

Q Will you tell me where in Vassalboro, Maine, you saw him, who
was present at the time, and what talk you had with Mr. Moore?

A On a Thursday night about ten o'clock, he came to the residence
of Charles Perkins and called me out, and asked me to step up the
road to his car, that he had a few things he would like to show me.
Mr. Moore and I sat in the front seat and Mrs. Lee and another
lady in the back seat.

Q Who is Mrs. Lee?

A That's the Deputy Sheriff.

Q And what is her full name?

OFFICER BROUILLARD: Mrs. Edith Lee.

Mr. Goodridge: Yes.

Mr. WILLIAMS: Was there anybody in back with Mrs. Lee?

Mr. GOODRIDGE: She had a lady in the back seat with her. I think

she was introduced afterwards as Mrs. Lee's sister. And then Mr. Moore took out this book of pictures, showed me some affidavits, and asked me if I knew those people and I told him I did, in fact I acknowledged all the book contained.

Q What was the substance of the affidavits?

A Well, there was none read to me. Only just showed to me, made by Lewis, Beecher, Hoxter, and the records of my convictions and the pictures.

Q That is, he showed you these affidavits which showed that you had previously been convicted of crime in New York State and that there was an indictment pending against you at the present time?

A Yes, shown to me. Moore said to me, "What I would like to know is what inducements were held out to you by Katzmann in your court trouble at Dedham; what inducements he held out to you there if you would testify on the Sacco and Vanzetti case," and I told him that I hadn't seen Mr. Katzmann and had no talk with him in regards to the trial, or had no talk with him in regards to my trouble there; that Attorney Mack of Quincy handled the case for me and I did just as he asked me to do. He then asked me if I had any talk with Williams, and I told him I did not have any talk with Williams until the morning I went to Dedham for the trial. And that I told Mr. Williams that I would rather not testify on the case and Mr. Williams told me that he thought it was the duty of any American citizen to tell what he knew. Mr. Moore asked me if I had talked with anybody in regards to the case, and I told him I had with Mr. Brouillard and Mr. Stewart; that Mr. Stewart came to my house with Mr. Brouillard when I lived at 127 Western Avenue, and that I didn't give him much information that evening; that Mr. Stewart wrote me a letter asking me to be at Dedham at a certain date as he would like to see me; that Mr. Stewart met me at that time and asked me to go to Dedham to identify Sacco, and I told him that that would be a useless trip that I had met Sacco twice previously and could readily identify him. Mr. Moore said that he could take me back to New York to answer the charges of the former indictment

that was pending against me, but that he didn't care nothing about the New York authorities or their case, but he wanted me to make a clean breast of what inducements were held out to me by the District Attorney, if I would swear on the Sacco case. And I told Mr. Moore if that was his game and he had played his cards, that I would play mine and go back to New York. Mr. Moore then told Mrs. Lee I was a fugitive from justice and it was her duty to take me back to Augusta for the New York authorities. I was then in the car. I asked them to take me to my home for a change of clothes, and I went in and got my wife and she rode back up to the house with us. When I got to the house I told my wife that I was going to Augusta with Mr. Moore. I changed my clothes and my wife came out to the car with me and she asked Mr. Moore when I would be back and he said in a couple of hours. Before we got to Augusta Mr. Moore said he thought I was foolish to not tell all that had transpired between Mr. Katzmann and me and save myself from the trouble of going back to New York. I told him that the cards were played and we would play them out. I was taken to the jail and the Sheriff would not accept me as a prisoner because they didn't have the proper papers and no warrant for my arrest.

Q Did Mr. Moore or Mrs. Lee have any papers or any warrant for your arrest with them so far as you know?

A No. From there, I was taken to Police Headquarters and they called up Judge Coney (Note: the spelling of this name is phonetic. Mr. Goodridge did not feel sure of this spelling.) Moore stated the case to them and Judge Coney instructed the police officer to hold me until morning, and he would issue the warrant and it was then one o'clock in the morning, and he did not care to come down to his office.

Q Did you hear the conversation with Judge Coney?

A Yes, sir.

Q Could you hear what he said.

A No, I didn't hear that, but I heard the police officer report to Mr. Moore what Judge Coney had said over the 'phone.

Q Did you stay at the jail overnight?

A I stayed at the police station over night. In the morning I was taken before Judge Coney, and Mr. Moore and Mrs. Lee were there and he asked Mrs. Lee if she had heard from New York in regards to her telegrams and she said she had not and he told her that he would give her twenty-four hours to hear from New York, or he would have to release me. Then Moore said that he had talked with the parties in New York, and they were anxious to prosecute the case and he knew that they would send for me. That he would telegraph to his officer in New York at once to see the District Attorney in Livingston County. And I didn't see Mr. Moore again until that evening when he came to the lock-up about 8:00 o'clock and I wouldn't talk with him.

Q What did he say to you at that time.

A Well, he said he wanted to talk about the case, and I said I had nothing more to say. And the next morning, Saturday morning, Judge Coney released me because he had heard nothing from the New York authorities. Now, that's the last I saw of Moore.

Q Have you heard from him since?

A Only in an indirect way that he went back to Maine, and that I wasn't there, and that he went to the neighbors and the minister trying to get affidavits about my character.

Q Do you remember anything more of the conversation that you had with Mr. Moore at that time that you have failed to tell us so far?

A Moore told me when I was in the machine that it had cost him ten thousand dollars and three months' time to look up my record, and that I was the hardest man he had ever bucked up against and that he would never have gotten the information that he did if it hadn't been for Mrs. Radcliff.

Q At the time that you went before the Superior Court in Dedham Mr. John Mack of Quincy handled your case for you as attorney?
