

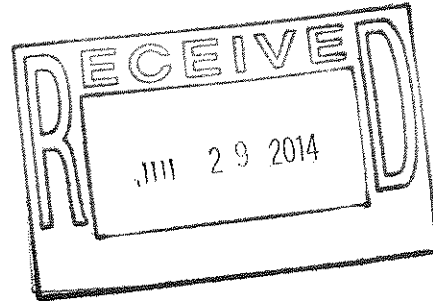

Dear, Governor: Deval Patrick,



Call to Cause

THE NEED

Bullying is an ongoing problem in the community. Students are especially susceptible to the effects of bullying which causes them to stop attending school and are afraid to report the bullying. More than 160,000 U.S. students stay home from school each day from fear of being bullied. One out of 4 teens are bullied. 9 out of 10 LBGT students experienced

harassment at school and online. There are about 282,000 students that are reportedly attacked in high schools throughout the nation each month.

THE SOLUTION

In response to reduced bullying Springfield Public Schools, the School H.U.G.S Bullying Prevention Program is formed. Rivera & Rivera Act Against Foreclosure Inc. : Schools H.U.G.S Bullying Prevention Program is ia local 501(c)(3) tax-exempt non-profit organization designed to prevent bullying in our Schools and the society through education and awareness. The objective of this project is to focus on youth between k-12 who have suffered emotional or physical harm due to bullying and may require the presence of reliable, trustworthy, caring adults in their lives.

OUR COMMITMENT

Schools H.U.G.S Bullying Prevention Program provides educational programs and resources to individuals, families, education and their communities. Our goal is to provide quality mentoring to 5 youth per month after the initial six months of creation of the program design for a total of 125 youth at the end of a two year period.

Schools H.U.G.S Bullying Prevention Program will be hosting our annual Anti-bullying event Saturday Oct. 18, 2014 at 10 am Blunt Park in
